Alderman Brian Butler, Public Safety Committee, reported one item on the agenda for consideration (Ordinance E, WCHS School Resource Officer Agreement). Finch Co. in a bid amount of \$572,949.80. He noted that with three bidders this time the amount came in \$30K less than the June bid where only there was only one bidder. He indicated that other than the waiver of the lot width requirement that was approved by the Planning & Zoning Commission at the initial final plat, it meets the City's subdivision code regulations as well as the County's zoning code regulations. He noted the minor change is due to Summit only having a 30' right-of-way along these lots and not the 40' that was previously thought when the final plat was approved on August 1, 2016. Adoption of this ordinance would revise language to reflect the proposed job titles of Public Works Director and Utilities Superintendent, amend the Administrative Services section to reflect the current structure of Department Director level employees, and allow the city to have a stand-alone Public Works Department, and a City Engineer. Alderman Cobb moved and Alderman Stevens seconded to adopt the ordinance as read. On roll call the vote was:

Adoption of this ordinance would continue the School Resource Program between the City of Washington and Washington Community High School which places one Washington Police Officer at the High School during school hours. Among other things, the agreement provides for the payment of \$80,000 to the City for services provided. These ordinances will be listed on the next meeting agenda for action. Alderman Butler moved and Alderman Cobb seconded to adopt the ordinance as read. On roll call the vote was:

1st reading ord, amending Chapter 72, parking regulations City Administrator Forsythe provided first reading of the following ordinance, by title and brief synopsis: an ordinance amending Chapter 72 of the Code of Ordinances of the City of Washington, Tazewell County, Illinois, entitled "Parking Regulations" to restrict parking on certain City streets. Adoption of this ordinance would prohibit parking for more than two hours while the high school is in session for the entirety of both sides on W. Adams Street, on Lincoln Street from Madison Street to W. Jefferson Street, on Tyler Street, and to prohibit parking during all hours on Garfield Street and Highland Place. The ordinance would also allow for permit parking for those residents living on the aforementioned portions of W. Adams, Lincoln, and Tyler. This ordinance will be listed on the next meeting agenda for action.
