Alderman Stevens asked about the status of EMA and who calls them out?

Chief McCoy advised that due to COVID concerns recent meetings with EMA members were canceled. They have been given updated radios, ID cards and shirts. When they are needed the EMA Coordinator notifies them of incident.

Alderman Stevens asked who activates the tornado sirens.

TC3 activates sirens for Washington. WPD also has the capability of setting them off from the upper and lower floors at the PD.

3. Approval of Minutes from October 19, 2020

4. Business Items

A. Discussion Regarding Reducing Waiting Period for Gaming License

The police department is asking what direction the Committee would like to go as it relates to reducing the gaming license wait from two years for an unlicensed business to one year. (Attachment of explanation in Agenda) Currently, there is an interested party wanting to buy a shuttered business that used to hold a liquor license in conjunction with the restaurant that would like an exception to the waiting period.

Discussion between all voting members included some background on the original reason for the ordinance:

- *2012 City voted to allow gaming.
- *2017 City created an ordinance instituting a two-year waiting period for unlicensed business to bring in gaming. This was done to eliminate creating mini casinos.
- *Concerns about opening a restaurant now with COVID shutdowns. *Is there a summary of a business plan available to this potential buyer?

After the discussion concluded the Committee has asked to see what a one year waiting period would like in an ordinance for a business that used to have a Class A license but is no longer open. Once finished, the PD could present it at a Public Safety Committee Meeting for further discussion.

B. License Plate Reader Consideration

The memo included in agenda captures the explanation of these. Deputy Chief Stevens pointed out that nobody in Central Illinois has these yet. This reader is on the leading edge and would assist in efficiency regarding crimes that happen within the City. There is even the possibility of partnering with private businesses to help offset the cost.

Committee questioned where the funds would come from within the budget? Do we really need this?

Chief McCoy and Deputy Chief Stevens have been invited by a couple of northern cities in Illinois to view the product. They will be going to gather more data.

Committee has no problem researching this further but is not in a hurry to OK spending at this time.

C. Washington Fire Department Contract Update

City Administrator Forsythe gave an overview of the current negotiations. An explanation is included in agenda.

D. Public Safety Committee Meeting 2021 Calendar
