City Council Meeting
Monday, September 20, 2021 at 6:30 p.m.
Library in Five Points, Washington

Call to Order Mayor Manier called the regular meeting of Monday, September 20, 2021 to order at 6:30 p.m. in the library at Five Points, Washington, 360 N. Wilmore Road, Washington, Illinois.

Roll Call Present and answering roll call were Alderpersons Adams, Blundy, Brownfield, Butler, Cobb, Dingleline, Stevens and Yoder.

Also Present City Engineer Dennis Carr, Planning and Zoning Director Jon Oliphant, Public Works Director Kevin Schone, City Clerk Valeri Brod, City Treasurer Abbey Strubhar, Police Chief Mike McCoy, Deputy Police Chief Jeff Stevens, and City Attorney Derek Schryer.

Pledge of Allegiance All present stood for the Pledge of Allegiance.

Agenda Review The agenda was reviewed and stood as presented.

Approve Consent Agenda Mayor Manier presented the Consent Agenda for approval of the following items:

Aldersperson Cobb moved and Aldersperson Brownfield seconded.

Aldersperson Stevens noted that the minutes should say "St. Marks Church" instead of "St. Pat's Church"

Audience Comments Katie Blanklieve, the Director of the Heart of Illinois Special Recreation Association came forth to comment on the Transportation Grant agenda item. She shared that they are a cooperative made of four park districts and they provide recreation programming for residents who have special needs. She explained that transportation

is an issue with her participants and with limited funding, they cannot provide transportation for everyone.

Christina Norris came forward to ask Council to imagine what it would be like to be disabled and have no independence. She stated that transportation is a basic skill and privilege. She went on to share that crossing The Square is hazardous due to lack of yielding cars. Ms. Norris shared that some residents have to choose between their job or staying at home to help their adult child. She shared that kids go from the high school setting with friends and resources to the home setting with no independence. She also shared that families with no means, may be left home alone. She shared that even our park district ages out at 12 years old and this refers to an actual year, not a mental year. She introduced her son who she said was a miracle, born at only one pound. She shared that he finished high school but cannot get to basic programs or to get groceries due to the lack of transportation. Ms. Norris asked for Council to support the transportation program which would include "even these residents".

Chairman Daniel Cobb, Finance & Personnel Committee, introduced Mr. Oliphant to share details about Section 5310 Transportation Grant Program Local Funding Contribution Consideration. Mr. Oliphant shared that they have sought grants to help fund this consideration and applications are due on October 1st. He also shared that the township started a similar transportation program for residents ages 65 years old and older and noted that Washington is a gray area because it lacks alternative transportation needs. Mr. Oliphant shared details about the way the program is to be funded and shared that the township has asked if the City would share in the funding expenses.

Washington Township Supervisor, Jim Bremner was present and shared that they have a transportation program for residents who are 65 years and older and who can get into vehicle unassisted. He shared that they receive calls for transportation for seniors and this can also include those with disabilities. Mr. Bremner shared that the Township has spoken to area medical facilities and they also identified this as a need. He shared that AARP notes that a lack of transportation leads to physical and mental deterioration. He went on to explain that We Care is the rural transportation program that is available only if either their start or destination is a rural location. He shared that CityLink follows the transit route which ends at Washington Plaza and the Agency on Aging Program is the only one who picks up anywhere and drops off anywhere but they only have one passenger van to serve three counties. Mr. Bremner also shared that the Township decided to work with the Morton/Washington taxi service and they seem to be the best because they are cost effective and will help with some mobility issues. Mr. Bremner stated that the Township is sharing a brochure in the community to help everyone understand the need and they are starting to get a response. He noted that they are partnering with CityLink/CityLift to see if they can come up with a grant to help. He shared that CityLink/CityLift can provide two buses each for 50 hours per week for an annual expense of approximately \$285,000. Mr. Bremner explained that enough funding can be found to get through this fiscal year and that the Township Board as approved this. He also noted that they can customize the program and limit days or hours to fit the community's need.

Mayor Manier expressed disappointment in the WE CARE program who does not come into the City. He also shared his support for this consideration.

Aldersperson Stevens shared her support of the program.

Aldersperson Cobb and other Council members would like to move forward with this program and explore funding options.

Mr. Oliphant shared that he will look at several funding options.

Aldersperson Cobb moved and Aldersperson Adams seconded.

Chairman Brian Butler, Public Safety Committee, introduced Police Chief Mike McCoy who shared that last week they signed an agreement with Tazewell County for a Mutual Aid Agreement. Chief McCoy introduced Deputy Chief Jeff Stevens to review a recent vicious animal hearing. He noted there were recent false claims against the Mayor, Police and City.

Deputy Chief Stevens referenced Chapter 91 in the City Code that explains if a dog that has bitten a person or animal without provocation, then there will be a required hearing. At this hearing, a judgment will be made. If they find the dog to be vicious, they will be required to have warning signage, a confinement structure, a muzzle when walked but not to be worn inside a residence, a one-time \$50 license fee to the City and insurance coverage of \$50,000. If a family doesn't want to do these requirements, they can rehome the dog with proper notifications given. Deputy Chief Stevens shared that there are recent social media posts regarding a vicious dog claim and feels they are acting out of emotion. Deputy Chief Stevens explained that fines given for a violation of a vicious dog ordinance are set by a judge in Tazewell County court and they range from \$100-\$500. He noted that the fee that was stated on the social media post was a fee for someone who wanted to let their vicious animal run free and the fine that was given to this case was \$100 and it was paid.

Chairman Mike Brownfield, Public Works Committee, introduced City Engineer, Dennis Carr to share details about Centennial Rec Trail. Mr. Carr stated that they brought this to Council in June and the low bid was approximately \$418,000 which was over budget. He noted at the time, they had decided to turn down the bid but worried that by turning down funding, it could hurt future job funding. Mr. Carr shared that they put the project out for rebid and received eight bids. The low bid was provided by Knapp Concrete for \$388,163. He noted that they would have until July to complete the project and this is similar to other projects where IDOT pays for it, then the City will reimburse IDOT after the job is completed. Mr. Carr stated that staff is asking if the City would want to continue this project.

Aldersperson Brownfield noted the extra funds needed and the risk of losing future funding if we turn this down.

Aldersperson Brownfield moved and Aldersperson Dingledine seconded.

Aldersperson Dingledine echoed Aldersperson Brownfield's sentiments. He noted that although we are almost doubled the initial estimates, he fears if we don't complete the project, it will hinder future projects. He also stated the need to be more diligent on future projects.

Mr. Carr provided updates on several projects which included the replacement of dead sod on Bobolink, delivery of sod on Lawndale, three remaining laterals on the Holland Project, laterals on Market and Main Streets, removals and grading on Hilldale, the gas shift on the North Street Culvert, discussions with Cullinan regarding last year's aggregate loss, the data gathering for the Stormwater Study, the Water Quality Study, and the Phase 2B Alternative Analysis which received five bids and will move forward to interviews with the selection committee.

Mr. Oliphant shared that the Core and Main project should break ground any day. Mr. Schone shared that Public Works has a watermain project that will require Spring Street to be closed. He shared that they will take the affected resident's garbage out to Spring Street to help. He also shared that they will address the alley leading to Parr Hue Street. He noted that they have received permission to use the alley but the barriers will go back to block the alley once the improvements are completed. Mr. Schone also shared that they will be putting in a hydrant at the lane. He shared a few details about the job process and stated they don't know what they will find when they start to dig. Mr. Schone also shared the Public Works is waiting for asbestos abatement at the Wastewater Treatment Plant.

Mayor Manier stated that the Fogging process was done well to help fix issues from last year and hopes this will help eliminate some of the old issues.

Chief McCoy shared that they used Code Red to alert the residents of Spring Street closing.

Mayor None provided at this time.

Mayor Manier provided the following resolution, by title and brief synopsis: A resolution accepting an agreement with the Illinois Department of Transportation to provide a local funding match for the Safe Routes to School Program projects on Grant Street.

Alderpersion Brownfield moved and Alderpersion Stevens seconded.

Alderpersion Butler asked for clarification about the entire cost of \$535,000. Mr. Oliphant shared that this would be the case if the sidewalk was taken all the way to School Street and noted that they are proposing to complete about half the length. Alderpersion Butler noted that there is a good sidewalk already on Washington Road and shared that he cannot support this due to lack of need. Alderpersion Brownfield explained that the direction from the Committee was for staff to include all three schools in the Safe Routes to School projects and staff did what they were asked. Alderpersion Butler noted that we shouldn't spend this money for 1/10 of a mile of sidewalk. Alderpersion Stevens stated the original conversation was referring the sidewalk that does not have a crosswalk. She noted the safety concerns for a safe way to cross the road. Alderpersion Stevens also noted that the original crosswalk sign was taken down when school street was redone because there wasn't a landing at the crosswalk and she feels this is needed for safety.

Alderson Stevens moved and Alderson Adams seconded.

Alderson Butler stated that he feels this is a sidewalk to nowhere and noted that schools can provide transportation to those who cross Business Route 24. He also shared that he would prefer to look at areas on Grandyle and Eagle Avenue. Alderson Stevens stated that since we provided the traffic lights, the City needs to provide a safe way to cross at them.

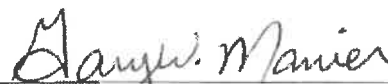

Gold Star Mother's and Family's Day

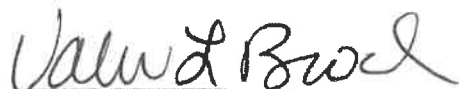
and I do further encourage the Citizens of Washington to display the United States Flag as a public expression of our gratitude and respect for our Gold Star Mothers and Families.
