SPECIAL CONDITIONS

1. Term of Contract

This Contract shall take effect May 1, 2022, and expire on April 30, 2023.

2. Industrial Grade Coarse Water Softener Salt

All Industrial Grade Coarse Water Softener Salt furnished under this contract shall meet **ANSI/NSF Standard 60** specifications.

3. Quantities

It is the intent of the City of Washington to purchase and receive approximately one thousand two hundred and fifty (1,250) tons of Industrial Grade Coarse Water Softener Salt for use by its Water Treatment Plants. This quantity is an estimate for canvassing purposes only and as such may not represent the actual quantities required during the term of any contract made pursuant to these specifications. Nothing contained herein shall be construed as an obligation of the City of Washington to order or pay for any quantity of material other than that amount determined to meet the actual requirements of the City. The right is reserved to increase or decrease the quantities shown herein at any time during the life of the contract. The City will be obligated to pay for only the actual quantities ordered and received.

4. Basis of Award

Bids will be canvassed on the basis of the unit price and extended total as shown on Page P-1 of the Proposal. The City reserves the right to waive technicalities or to reject any and all bids when, in the opinion of the City Council, the best interests of the City of Washington will be served by such action.

5. Ordering and Delivery

Orders shall be placed by telephone direct to the Contractor by personnel of the City of Washington, Department of Public Works. A list of authorized personnel will be furnished to the Contractor upon request.

The ordered quantities shall be delivered no later than three business days after placement of the order.

6. Billing

All invoices for accepted quantities should be sent to the City of Washington, 301 Walnut Street, Washington, Illinois 61571. All invoices must clearly show the description, quantity received, unit price, and City of Washington's Purchase Order number.

7. Price Escalation

The prices quoted herein shall remain firm for the contract period.

8. Certification of Compliance

In accordance with Article 33E of the Criminal Code of 1961, as amended, the bidder is required to fill out and submit with his proposal the Certification of Compliance included with this bid document.

9. Exceptions to Specifications

Any exceptions to these specifications shall be clearly explained on a separate page by the bidder on his firm's letterhead, to be attached to and submitted with these documents prior to or at the time of bid opening. Should a bidder submit a proposal without a separate statement of exception, it shall be assumed the proposal is in full compliance with these specifications.

10. Corrections

All prices and notations must be typed in or written in ink.

CERTIFICATION OF COMPLIANCE

The undersigned, being first duly sworn on oath, deposes and states that he has the authority to make this certification on behalf of the bidder.

- (1) the prices in this bid have been arrived at independently, without consultation, communication, or agreement, for the purpose or restricting competition, as to any matter relating to such prices with any other bidder or with any competitor;
 - (2) the prices which have been quoted in this bid have not been knowingly disclosed by the bidder and will not be knowingly disclosed by the bidder prior to opening directly or indirectly to any other bidder or to any competitor; and
 - (3) no attempt has been made or will be made by the bidder to induce any other person or firm to submit or not to submit a bid for the purpose of restricting competition.
- (b) The undersigned further states
- (1) he is the person in the bidder's organization responsible within that organization for the decision as to the prices being bid herein and that he has not participated, and will not participate, in any action contrary to (a)(1) through (a)(3) above; or
 - (2)(a) he is not the person in the bidder's organization responsible within that organization for the decision as to the prices being bid herein but that he has been authorized to act as agent for the persons responsible for such decision in certifying that such persons have not participated, and will not participate, in any action contrary to (a)(1) through (a)(3) above, and as their agent does hereby so certify; and (b) that he has not participated, and will not participate in, any action contrary to (a)(1) through (a)(3) above.
- (c) The undersigned certifies that the bidder is not barred from bidding on this contract as a result of a conviction for the violation of State laws prohibiting bid-rigging or bid-rotating.
- (d) It is expressly understood that the foregoing statements, representations, and promises are made as a condition to the right of the bidder to receive payment under any award made hereunder.
