Public Hearing

A public hearing for the purpose of discussing the proposed 2015 City of Washington Tax Levy was opened for comment at 6:30 p.m. in the Library Meeting Room at Five Points Washington.

Present were Mayor Manier, Aldermen Brownfield, Brucks, T. Gee, Moss, Dingledine, J. Gee, and Maxwell, Controller Joanie Baxter, Director of Public Works Ed Andrews, P & D Director Jon Oliphant, Police Chief Don Volk, City Treasurer Ellen Dingledine, City Clerk Pat Brown, Attorney Nicole Meyer (Davis & Campbell), and members of the press.

Controller Baxter shared a summary of the proposed tax levy increase noting the following: 1) the City's actual 2014 property tax extension for taxes paid in 2015 is \$1,225,385; 2) the City's proposed 2015 property tax levy for taxes paid in 2016 is \$1,410,250; 3) the difference being \$184,865 or 15.09%; and 4) the use of the funds are broken down as \$945,000 for pension/retirement costs, \$75,000 for tort judgments/liability, \$32,000 for audit, \$3,300 for civil defense, and \$354,950 for general fund. Mayor Manier shared that the proposed levy has been discussed at several meetings and the 15.09% is misleading as we are catching up from last year with our decrease in assessed valuation due to the tornado impact. Controller Baxter shared that the assessed valuation increased from \$292,078,141 in 2014 to the projected assessed valuation of \$336,144,960 for 2015. She shared that this projected levy will keep the tax rate the same at \$.41954 per \$1,000 of assessed valuation. Mayor Manier shared that residents who have rebuilt their homes and are assessed at a higher rate than their previous home will see a slight increase in the City's portion of their tax bill and that those who have remained status quo may see a decrease in the City's portion.

Public Comments

City Treasurer Dingledine shared that in maintaining the tax rate of \$.41954 the levy amount is just under the pre-tornado level of \$360,000. Alderman J. Gee reminded residents that the City's portion of their tax bill is 5% and the remaining percentages are from other taxing bodies.

DATE: December 22, 2015

On February 2, 2015, the City entered into a TIF redevelopment agreement with Black, Black & Brown for assistance to make some exterior building improvements to their business at 115 Washington Square. The work included repainting the brick exterior to coordinate with the brick on either side of the building. It also included the installation of a black awning over the front window that generally matches the other awnings on the north side of the Square. Finally, a new 10'x2' sign replaced the existing sign.

Staff has reviewed the invoices that were submitted recently for this project, which totals \$7,799.95. This was slightly less than the original quotes of \$9,235. Each of the items was approved for a base 20-percent base subsidy. The agreement states that the City shall pay the subsidy in one installment upon completion of the project. As a result, staff requests authorization to make the payment in an amount of \$1,560 to Black, Black & Brown.

This item is scheduled for consideration as a consent agenda item at the January 4, 2016, City Council meeting.

First Reading Ordinance - Residential Beekeeping

DATE:

December 18, 2015

Staff receives periodic interest from residents about housing animals on their property other than cats and dogs. A resident in the 800 block of South Elm asked earlier in the year about keeping bees on their property. The resident was informed that Section 91.09 of the City Code currently does not allow for bees to fly at-large in the city limits.

The resident met with the Public Works Committee and staff was asked to draft an ordinance that would allow beekeeping in residential zoning districts following the approval of a special use permit. The attached ordinance utilizes many of the regulations found in other Illinois communities that currently allow beekeeping including provisions that address registration, maximum beehive quantity, maintenance, setbacks, fencing, and enforcement.

A first reading ordinance is scheduled for the January 4, 2016, City Council meeting with a second reading scheduled for January 19.

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF WASHINGTON, ILLINOIS BY AMENDING CHAPTER 91 ENTITLED "ANIMALS" OF THE CODE OF ORDINANCES OF THE CITY OF WASHINGTON, ILLINOIS, REGARDING THE ALLOWANCE OF BEES WITHIN THE CITY LIMITS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WASHINGTON, TAZEWELL COUNTY, ILLINOIS, as follows:

Section 1. That §91.09 of the Washington Municipal Code of Ordinances titled "Bees" is hereby amended by deleting § 91.09 in its entirety and by substituting the following as §91.09 in lieu thereof:

"§ 91.09 BEES

- (A) Any person keeping honeybee hives must register annually with the Illinois Department of Agriculture, per Illinois State Statute.
- (B) Beekeeping shall be allowed only after a special use permit is granted to the owner of land in a residential zoning classification by the City Council after a public hearing and recommendation by the Planning and Zoning Commission. If a tenant applies for a special use permit, with respect to beekeeping, the tenant shall include in his application for a special use permit the owner's written consent to the tenant's keeping of bees on the land.
- (C) Registration: If a special use permit is granted to the owner by the City Council, a beekeeping permit must be issued by the Code Enforcement Officer. Beekeeping permits must be renewed annually by January 31 of each calendar year. Beekeeper permit registration shall include:
 - (1) Submittal of proof of registration of the hives with the Illinois Department of Agriculture;
 - (2) Submittal of a site plan showing the location of the hive(s) and fencing:
 - (3) Be in compliance with the other requirements of this Section;
 - (4) Payment of a twenty-five dollar (\$25) application fee;
 - (5) No permit shall be assigned or transferred to any other person or location; and
 - (6) Any violation of the requirements of this Section can result in revocation of the permit. Once a permit is revoked, it shall not be reissued.
- (D) No other stinging insects, such as yellow jackets, hornets, other varieties of bees, including African honeybees, or wasps, including Vespidae, shall be contained on private property.
- (E) Maximum Quantity: A maximum of two (2) hives is permitted per property.
- (F) Maintenance: It shall be the duty of any person keeping honeybees on their property to maintain each colony so as not to create a public nuisance.
- (G) Beekeeping Components: Beekeepers shall ensure that no bee comb, wax, or other materials are left upon the grounds of the beehive site. Beekeepers shall promptly store or dispose of any bee comb, wax, or other materials which have been removed from the beehive in a sealed container or within a building or other bee proof enclosure.
- (H) Location: Hives shall only be located within the rear yard of the property.
- (I) Setbacks: Hives shall not be located within twenty-five (25) feet of any property line.

- **(J)** Fencing: A six-foot (6') tall privacy fence or other solid flyway barrier must enclose the rear yard. The beekeeper must post a prominent weatherproof sign on each side of the fence facing abutting properties the registration number issued by the Illinois Department of Agriculture for the keeping of bees and language that makes clear that bees are on the premises. The sign must be visible and easily read from outside the property.
- (K) Water: Each beekeeper shall ensure that a convenient source of water is available at all times to the honeybees on the property at which the hive is located so that the honeybees are discouraged from congregating at swimming pools, hose bibs, pet water bowls, birdbaths, or other water sources at which they may come in contact with humans or domestic pets. The water source must be maintained so as to not create a breeding site for mosquitoes.
- (L) Enforcement: The City of Washington (COW) shall enforce this ordinance. Once a beekeeping permit is issued, proper officers of the COW are authorized and empowered, during reasonable business hours, to enter the premises to inspect hives or colonies for the purpose of ascertaining the variety of insects occupying the hives, conditions of health, and management of crowding. Additionally, the Tazewell County Health Department shall also be authorized and empowered, during reasonable business hours, to enter the premises when there are potential problems that could be detrimental to the public's health.
- (M) Penalties: See §91.99."
- That this ordinance shall be in full force and effect from and after its passage, approval, Section 2. and publication as provided by law.

Section 3. That all ordinances or parts thereof in conflict herewith are hereby expressly repealed.

AN ORDINANCE AUTHORIZING AN ADDENDUM TO MUTUAL AID BOX ALARM SYSTEM AGREEMENT

WHEREAS, the <u>Constitution of the State of Illinois</u>, 1970, Article VII, Section 10, authorizes units of local government to contract or otherwise associate among themselves in any manner not prohibited by law or ordinance; and,

WHEREAS, the "Intergovernmental Cooperation Act", 5 ILCS 220/1 et seq., provides that any power or powers, privileges or authority exercised or which may be exercised by a unit of local government may be exercised and enjoyed jointly with any other unit of local government; and,

WHEREAS, Section 5 of the "Intergovernmental Cooperation Act", 5 ILCS 220/5, provides that any one or more public agencies may contract with any one or more public agencies to perform any governmental service, activity or undertaking which any of the public agencies entering into the contract is authorized by law to perform, provided that such contract shall be authorized by the governing body of each party to the contract; and,

WHEREAS, the Mayor and the City Council of Washington, Illinois have determined that it is in the best interests of the City and its residents to enter into an intergovernmental agreement to secure to each the benefits of mutual aid in fire protection, firefighting and the protection of life and property from an emergency or disaster and to provide for communications procedures, training and other necessary functions to further the provision of said protection of life and property from an emergency or disaster.

SECTION ONE: That the Mayor and the Clerk be and are hereby authorized to execute an Agreement Addendum for participation in the Mutual Aid Box Alarm System, a copy of said Addendum

being attached hereto and being made a part hereof.

MUTUAL AID BOX ALARM SYSTEM FIRST ADDENDUM TO MABAS MASTER AGREEMENT

This First Addendum to the Mutual Aid Box Alarm System ("MABAS") Master Agreement in the State of Illinois, last amended prior to 2000, is meant to incorporate in its entirety the terms included within the Master Agreement except as specifically changed herein. In the event there is a conflict between the terms and conditions of the Master Agreement and this Addendum, this Addendum shall be controlling.

As the cost of lending mutual aid support has increased in recent times, communities have determined it necessary to agree in advance on cost reimbursement issues prior to the occurrence of an actual emergency. Mutual aid agreements such as the MABAS Master Agreement have served as the foundation for navigating cost issues and engaging in these agreements prior to the emergency avoid post-emergency concerns on cost reimbursement.

SECTION FIVE - Compensation for Aid is amended to read as follows:

Equipment, personnel, and/or services provided to this Agreement shall be at no charge to the party requesting aid for the first eight (8) consecutive hours of aid provided to the Stricken Unit; however, any expenses recoverable from third parties shall be equitably distributed among responding parties. Day to day mutual aid should remain free of charge and the administrative requirements of reimbursement make it unfeasible to charge for day-to-day mutual aid. Nothing herein shall operate to bar any recovery of funds from any state or federal agency under any existing statute.

Any Aiding Unit is empowered to and may charge a Stricken Unit for reimbursement for costs of equipment, personnel, and/or services provided under this Agreement for terms of more than eight (8) consecutive hours under the following terms and conditions:

- 1. The amount of charges assessed by an Aiding Unit to a Stricken
 Unit may not exceed the amount necessary to make the Aiding
 Unit whole and should only include costs that are non-routine in
 nature.
- The Aiding Unit must assess no more the "usual and customary" charges for personnel costs pursuant to a collective bargaining agreement, benefit ordinance or compensation policy.

- 3. The fee structure for apparatus and equipment shall be based on FEMA or OSFM rate schedules. If a particular piece of apparatus or equipment is not listed within the FEMA / OSFM rate schedules, a market rate for reimbursement shall be established.
- 4. In no event shall the amount assessed by an Aiding Unit to a Stricken Unit exceed the amount of fees permitted to be assessed under Illinois law.
- 5. Aiding Units must invoice the Stricken Unit within thirty (30) days after the completion of the emergency; Once thirty (30) days pass, the aid shall be considered to be a donation of service.
- 6. Mutual Aid and assessing costs for mutual aid cannot in any way be conditioned upon any declaration of a federal disaster.

Member Units are encouraged to consider the adoption of internal policies establishing procedures for cost reimbursement on MABAS mobilizations pursuant to established MABAS procedures for collection and submission of funds.
