2017 Consumer Confidence Report (CCR) Notification

March 2017

Dear Water Supply Official:

The purpose of this memorandum is several-fold: first, to remind you that you must prepare and deliver a 2017 Consumer Confidence Report (CCR) to all your customers no later than July 1, 2017. This CCR must be based on 2016 data, unless the monitoring frequency is less than annual, but within five years. A copy of the CCR and the CCR Certification form is due to the Illinois EPA no later than July 10, 2017. Your customized 2017 CCR (calendar year 2016 data) is now available on the Internet. After you include any additional information (e.g., violation explanations, source water systems' data table, etc.), you will be able to photocopy and distribute this report. To get your report, go to the following Internet web address:

(Instructions: Click the "Review Consumer Confidence Data" tab located on the bottom left).

If you choose to use the report we generate, you must review the data carefully. If any errors or discrepancies are found, all applicable edits/additions/corrections must be made to the report prior to distribution. You do not have to get your edits/additions/corrections approved by the Illinois EPA prior to issuing your CCR. You can also use the CCR Template associated with the Sample Collectors Handbook. This document will open in your word processing application and can be easily edited.

You may also choose to use the U.S. EPA's CCR writer. The CCRiWriter is a web-based program that allows water system operators or designated personnel to enter information and data through a series of questions. Detailed CCR instructions, the self-assessment check list, regulation requirements, and delivery methods are listed in Chapter 2 of the Sample Collectors Handbook (SCH). It is recommended that you review this chapter prior to issuing your CCR. The self assessment is simply a "check-list" of the CCR requirements and will help insure that your CCR includes all of the required elements. ****ELECTRONIC DELIVERY INFORMATION****

The IEPA will accept the <u>electronic direct delivery</u> of the CCR to your customers to satisfy the CCR customer delivery requirements. This decision is based upon the U. S. Environmental Protection Agency's Consumer Confidence Report Retrospective Review Analysis, which was finalized in a Memorandum on January 3, 2013. This method of direct delivery (Method A) does not affect your ability to use the Optional Method of Delivery Waivers for systems serving less than 10,000 customers.

It is important to note, Public Water Systems must ensure delivery of the CCR to each of their bill paying customers, which means more than one method of delivery may be necessary, such as a combination of email communications, paper copy delivery, etc. Public Water Systems can distribute the CCR electronically to their customers using the following approved methods:

1. Requirements for E-mail Delivery to the Customer

- a) The subject line of the email must contain "2017 CCR", the Public Water System Identification Number (PWSID Number) and the Public Water System's Name.
- b) The CCR must either be embedded in its entirety in the email message, have the CCR as a file attachment in PDF format, or contain the direct URL¹ to the CCR.
- c) The URL must take the customer directly to the entire CCR so that the customer does not have to retrieve the CCR by navigating through another website. The email must also contain a description explaining the purpose and content of the URL in the email.
- d) The email must also contain information on how the customer may obtain a paper copy of the CCR (i.e. by calling a phone number)
- e) If the PWS receives a message that the email was undeliverable, the PWS must utilize another method to ensure the customer receives the CCR (i.e. mail a paper copy)

2. Requirements for Mailing the Direct CCR URL to the Customer

- a) The direct URL to the CCR must be printed directly on a water bill, a bill insert, newsletter, or separate mailing. <u>It must be a direct URL</u>; you can't send the customer to a website where they must then click or download the report.
- b) It must be clear and in a font that is at least as large as the largest font used.
- c) **A short description explaining the information available must accompany the URL.
- d) Must provide information on how the customer may obtain a paper copy of the document if they choose not to access the CCR by using the URL (i.e. by calling a phone number)
- e) Submit a copy of the URL notification in addition to the CCR, and CCR certification form.

The use of social media such as Twitter, Facebook, and automated telephone notification systems do not meet the "directly deliver" requirement of the CCR Rule and therefore, cannot be used. They can be used as an additional "good faith" effort to reach all consumers.

CCR Method of Delivery Instructions

^T In computing, a uniform resource locator (URL) is a specific character string that constitutes a reference to an Internet resource.

^{** (}example language) Go to <u>www.anytownwater.org/2017waterreport.pdf</u> to view your annual water quality report. This report contains important information about the source and quality of your drinking water during 2016. For a paper copy, call [(555) 555-5555].

CCR Delivery Requirements

The method that your water system qualifies for is identified on your "2017 Consumer Confidence Report (CCR) Certification Form", only one method of delivery is required.

METHOD A - Direct Delivery - All systems can use Method A

Option 1

The CCR must be delivered to all customers by direct mail or hand delivery by July 1, 2017.

This method is to be used if a water system did NOT qualify for a Method of Delivery Waiver or your water system chooses not to use the waiver.

Option 2

Electronic CCR (eCCR) Delivery to each customer will be considered direct delivery if the water system provides a notification of a direct URL to their CCR. Notification to customers can be made via water bills, newsletter, separate mailing, or e-mail delivery by July 1, 2017. The notification of URL availability must also provide a brief explanation of the URL content and an alternative method for a customer to request a paper copy of the report be mailed to them. Additional information about electronic CCR delivery can be found in the Sample Collector's Handbook (SCH) page 19. The SCH can be viewed and/or downloaded at the following Internet web address:

Both direct delivery methods must also provide good faith efforts to reach all non-bill paying consumers. If your water system serves 100,000 or more people, the CCR must also be posted on a publicly accessible Internet site. Mail a copy of the CCR, the CCR Certification Form, and the URL notification, if applicable, prior to July 10, 2017.

METHOD B - Population 501 to 10,000 (optional, can use method A instead of B)

This CCR method of delivery is intended to allow financially limited water systems that serve a direct population between 501 and 10,000 persons and have had no drinking water violations during 2016 to forego the cost of printing and direct mail delivery. This waiver has no effect on the required content of the report. The use of the waiver is "optional" and your supply may still choose to use Method A - direct delivery.

Although direct mail delivery of the CCR to each customer is not required, you are still required to complete ALL of the following if you choose to use the wavier:

- 1. Prepare the CCR;
- 2. Publish the entire CCR in one or more local newspapers (CCR must be printed in a conspicuous location and in print size which is easily read) by July 1, 2017;
- 3. Inform the customers by July 1, 2017 that the reports will not be mailed (this can be added to the newspaper publication);
- 4. Make the reports available upon request;
- 5. Mail a copy of the CCR, newspaper clipping, and notice of availability to the Illinois EPA along with the CCR Certification Form by July 10, 2017.

METHOD C - Population 500 or less (optional, can use method A instead of C)

This CCR method of delivery is intended to allow financially limited water systems that serve a direct population of 500 or less persons and have had no drinking water violations during 2016 to forego the cost of printing and direct mail delivery. This waiver has no effect on the required content of the report. The use of the waiver is "optional" and your supply may still choose to use Method A – direct delivery.

Although direct mail delivery of the CCR to each customer is not required, you are still required to complete ALL of the following if you choose to use the waiver:

- 1. Prepare the CCR;
- 2. Provide notification to customers <u>by July 1, 2017</u> that a CCR was prepared and is available upon request; this notice of CCR availability must be posted in a conspicuous location, provided directly to each customer, or published in a local newspaper. Sample language is in the Sample Collector's Handbook on the Illinois EPA Website.
- 3. Make the reports available upon request;
- 4. Mail a copy of the CCR and notice of availability to the Illinois EPA along with the CCR Certification Form by July 10, 2017.
