Planning and Development Director Jon Oliphant shared that staff received a request from Katie and Kevin Beale to operate a residential non-owner-occupied short-term rental at 301 S. Main Street located on the southeast corner of South Main and Holland. He explained that the property is small at less than one tenth of an acre, zoned R-1A (single family residential), and meets the short-term rental regulations per the ordinance approved by the council last year. He added that staff completed the required inspection ensuring the structure doesn't pose life or public safety risk to occupants and added that staff recommends approval for special use.

Katie Beale shared that the rental use will likely be short lived dependent upon possible family use of the property. They don't anticipate high use of the rental or that neighbors will notice any change. Lawncare will remain the same. She added that she's happy to answer any questions. Commissioner Burdette asked if it would be a one family rental and Katie clarified it's a one-bedroom property. Commissioner Scott and Planning and Development Director Oliphant referenced the .08 acre and significantly small size of the lot. It was confirmed there is no structure close to the home.

At 6:35 p.m., Commissioner Burdette closed the public hearing.

Commissioner Milot motioned to accept the request; Commissioner Reeder seconded.
