### DRAFT OF MINUTES FOR CONSIDERATION AND COMMENT

### CITY OF WASHINGTON PUBLIC SAFETY COMMITTEE MEETING AUGUST 15, 2016

Alderman Butler called the meeting to order at 5:30 P.M.

- 3. APPROVAL OF MINUTES FOR THE JULY 11, 2016 MEETING: MOTION BY Mr. Brownfield, second by Mr. Butler. Minutes unanimously approved as submitted by D.C. Stevens.
- 4. BUSINESS ITEMS:
  - a. MONTHLY REPORT: Chief Papis presented the monthly activity report for the police department. He noted that a new automated way of gathering statistics from the records management system will produce more consistent results, but accurate comparisons would necessarily take a year when comparing to prior years. There were no significant trends to report.
  - b. DALLAS ROAD: Mr. Andrews referenced the prior materials distributed on this topic and noted that the City obtained 70% funding to build Dallas Road from the federal government subject to a contract that, among other things, requires the City to maintain the functional class the road, including the speed limit, as reducing the speed limit reduces the level of service. Andrews summarized federal and IDOT road criteria applicable here. Mr. Butler asked why IDOT would care about a local road and noted it's similarity to Newcastle, Wilmore, and Jefferson Streets, all of which have a 25 M.P.H. speed limit. Butler said he believes this is the issue in terms of appearance to citizens. Andrews noted the original agreement addressed speed, which is in the agreement as 30 M.P.H. Butler asked if there is a risk of having to return the funding used if the City adjusts the speed downward. Andrews noted he has no experience in violating such an agreement but knows that in some instances the Federal government has demanded repayment of funds. Andrews noted Dallas is classified as a collector and its current use is consistent with that class. Andrews noted he examined crash data and used inputs most favorable to a speed reduction argument and still determined that engineering standards call for a 30 M.P.H. limit. Andrews recommends no change in the limit. Chief Papis said that based on the available information, the police department concurs. Butler said that there is not enough information to justify reducing the speed and noted the City must maintain enforcement and speed control efforts. Butler noted prior

consideration of a static speed display sign, but the expected cost, pot3entially over \$4,000, is prohibitive. Mr. Brownfield agreed there is not sufficient justification to reduce the speed limit.

#### c. 911 CONSOLIDATION UPDATE:

Deputy Chief Stevens reported that on August 8, the Statewide 911 Coordinator issued her ruling adopting the ALJ position on Tazewell's waiver request, meaning the County has until July 1, 2019 to complete consolidation. This was the expected ruling and is a short time frame for completion. The Tazewell ETSB currently operates on financial and personnel resources that are not conducive to ongoing operations. There are barriers to agreements in implanting consolidation based on varying positions of affected entities, such as agencies currently served by a consolidated center taking the position that the order should not affect them, the County's normally parsimonious history, including East Peoria's rebuffed attempts to obtain money from the County Public Safety Tax and various views about the propriety of using ETSB to force dispatch consolidation. The Consolidation Committee consists of members for whom this is an additional duty. It is critical that the County recognize its responsibility in this process to facilitate consolidation according to statute.

- d. WCHS Traffic Flow Update: Chief Papis noted that the PD and WCHS collaborated on a traffic flow pattern we think best fits the needs of the school and community and the PD will monitor the results and adjust as needed. Mr. Brownfield noted that busses have in the past exited the south WCHS drive to Bondurant and proceeded to the Peoria intersection. Papis said the PD would adjust as required by the traffic flow. Andrews noted that Public Works will replace the permanent "no parking" signs on Jefferson near the high school with more explicit "no stopping, standing, or parking" signs.
- e. Remote Warning Siren Activation Update: On July 13, Mr. Culotta distributed to Committee members the quote from Ragan Communication for a "reset" button in the PD ground floor for use in re-sounding the sirens in the event the main floor was evacuated. That quote is for \$1,705. Stevens noted that another referenced amount, approximately \$15,000, was for upgrade of the city's sirens to 2-way communication to allow remote testing and diagnoses. Mr. Butler and Mr. Brownfield agreed that the PD should assemble a staff report for consideration by the whole Council on September 5.
- f. Stevens noted the Police Department is seeking Committee and Council guidance on completing the scheduled and budgeted replacement of a 2008 and a 2009 squad car. The Department sought bids from local and out-of-area dealers and awaits Council guidance regarding a vendor for this purchase. We plan to replace a 2008 Crown Victoria with old-style markings and an unmarked, patrol use 2009 Explorer. Mr. Butler and Mr. Brownfield noted potential claims of conflict based on relations to a vendor and

wished to refer the matter to the Committee of the Whole on September 12. Mr. Butler and Mr. Brownfield said they agreed with replacing cars that require replacement.

#### 5. OTHER BUSINESS:

- a. Regarding the street name signs for the Nofsinger/Boyd Parkway intersection, Mr. Andrews said IDOT will allow signage within certain parameters and Public Works is working to develop signage appropriate for the 55 M.P.H. roadway.
- b. Mr. Brownfield asked about the status of no parking signs on South Cummings. Andrews noted Public Works can install the signs removed from Jefferson near the high school and use other existing stock. Andrews said the work will be performed as the opportunity arises.
- 6. Mr. Brownfield motioned for adjournment, seconded by Mr. Butler. The meeting was adjourned at 6:20 P.M.

**FOR A PUBLIC EVENT** 

Please find enclosed in your City Council packets for your review and deliberation a City of Washington resolution that authorizes the partial closure of the Washington Square / Illinois Business Route 24 on Saturday, September 24, 2016 for the "Washington Autumn Fest".

The approval of this resolution is required in order to receive permission from the Illinois Department of Transportation to partially close the Square.

## RESOLUTION NO.

## RESOLUTION FOR TEMPORARY CLOSURE OF A STATE – MAINTAINED ROADWAY FOR A PUBLIC EVENT

WHEREAS, The City of Washington, Tazewell County, Illinois, Chamber of Commerce is sponsoring the "Washington Autumn Fest" public event, which constitutes a public purpose; and

WHEREAS, the "Washington Autumn Fest" will require the temporary, partial closure of the Washington Square and Illinois Business Route 24, a State of Illinois in the City of Washington from 4:00 P.M. to 9:00 P.M. on Saturday, September 24, 2016; and

WHEREAS, Section 4-408 of the Illinois Highway Code authorizes the Department of Transportation to issue permits to local authorities to temporary close portions of state highways for such public purposes;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WASHINGTON, TAZEWELL COUNTY, ILLINOIS, that permission to partially close Illinois Business Route 24 at the Washington Square as above designated be requested of the Illinois Department of Transportation.

BE IT FURTHER RESOLVED that the closure shall occur during the approximate time period between 4:00 P.M. and 9:00 P.M. on Saturday, September 24, 2016.

**BE IT FURTHER RESOLVED** that this closure is for a public purpose of a "Washington Autumn Fest" public event.

BE IT FURTHER RESOLVED that traffic from that closed portion of the highway shall be detoured over routes with an all-weather surface that can accept the anticipated traffic, which will be maintained to the satisfaction of the Department and which is conspicuously marked for the benefit of traffic diverted from the state highway. The route shall be as follows: W/B Illinois Business Route 24 traffic will be routed N/B at Pine Street to Jefferson Street then diverted W/B on Jefferson Street to S/B Wood Street then back W/B on Illinois Business Route 24. E/B Illinois Business Route 24 traffic will not be affected.

**BE IT FURTHER RESOLVED** that the City of Washington, Tazewell County, Illinois assumes full responsibility for the direction, protection and regulation of the traffic during the time the detour is in effect.

**BE IT FURTHER RESOLVED** that Police Officers, at the expense of the City of Washington, be positioned at each end of the closed section and other points as may be necessary to assist in directing traffic through the detour.

**BE IT FURTHER RESOLVED** that such signs, flags, barricades, etc. shall be used by the City of Washington as may be approved by the Illinois Department of Transportation. These items shall be provided by the City of Washington

BE IT FURTHER RESOLVED that the closure and detour shall be marked in accordance with the Illinois Manual on Uniform Traffic Control Devices for Street and Highways.

**BE IT FURTHER RESOLVED** that the City of Washington hereby agrees to assume all liabilities and pay all claims for any damage which shall be occasioned by the closing of the described above.

BE IT FURTHER RESOLVED that the City of Washington shall provide a comprehensive general liability insurance policy or an additional insured endorsement in the amount of \$1,000,000.00 dollars per person and \$500,000.00 aggregate which has the State of Illinois Department of Transportation and its officials, employees and agents as insureds and which protects them from all claims arising from the requested road closing.

**BE IT FURTHER RESOLVED** that a copy of this RESOLUTION be forwarded the Department of Transportation to serve as a formal request for the permission sought in this resolution and to operate as part of the conditions of said permission.
