

CITY ENCOURAGES AUTOPAY OPTION FOR WATER BILLS



Did you know that 1 out of every 3 water payments made is through the AutoPay (also known as Electronic Debit) payment option? This option is not only commonly used but also very convenient for both residents and the City alike. It is the most efficient and cost-effective method to process and thus helps keep overall utility collection costs in check!

In addition to being convenient, payment of water bills through AutoPay reaps the following benefits for customers:

- NO fees charged for this service.
- NO need to worry about lost utility bill.
- NO need to write a check each month.
- NO late fees as bills are always paid on time.
- NO fear of disconnection for overlooked payment.
- STILL receive a copy of bill with usage and amount due indicated that will be debited from bank account on the 20th of the month.

DEVELOPMENT HAPPENINGS...

Special Census Completion

The Census Bureau recently wrapped up their on-site operations associated with the completion of a Special Census in Washington. This has been done to count those

new housing units within areas of the city that have experienced the most growth since the last decennial Census in 2010. As required by the Census Bureau, ten temporary employees were hired to assist with the enumeration. The operation went very well and is ahead of schedule. The City anticipates receiving a revised housing unit and population count in the next 90 days.

Illinois municipalities receive shared funds from the State for income, use, and motor fuel taxes on a per capita basis. Once the new population is certified by the Census Bureau, it is sent to the Illinois Department of Revenue and the City should receive new revenue based on this growth by this summer. The population and resulting new revenue would be in place until the 2020 Census is completed and that certified population is certified in the summer of 2021. Thanks to all of the residents within the neighborhoods that were subject to the enumeration for your assistance!

Bike Friendly Community Designation

The City of Washington has been named a Bronze Bike Friendly Community (BFC) award recipient by the



League of American Bicyclists (LAB). Washington was the only recipient of the award this year and joins 15 other cities in Illinois as BFC designees. That organization accepts applications bi-annually and communities must show proficiency in the "5-E" categories: Engineering, Education, Enforcement, Encouragement, and Evaluation.

Community The City is fortunate to have some great partners who promote bicycling in Washington. Students are taught early in their education about the Rules of the Road and the many

benefits of biking. The City continues to try to increase riding opportunities, via the off-road trail system and recently with the first sharrows in Tazewell County. Funding has been secured for the construction of a 1.3-mile extension of the Cruger Road trail between Nofsinger Road and N. Main Street and from N. Main to Washington Middle School. This will be completed in 2018. Funding is also in place for the completion of a one-mile trail on McClugage Road and Centennial Drive that will terminate at School Street. Completion is anticipated by 2019.

PUBLIC WORKS DEPARTMENT NPDES What "?"

The National Pollution Discharge Elimination System (NPDES) is a provision of the Clean Water Act which in 2003 was expanded under Phase II to include all municipal separate storm sewer systems (MS4s) in urbanized areas. The City of Washington has been under an operating permit with the Environmental Protection Agency (EPA) for NPDES Phase II since that time for its 44 miles of storm sewer and associated outfalls into the Ten Mile and Farm Creek drainage sheds.

In the Summer of 2017, the City expanded its annual detention basin inspections to include privately owned basins. In past years, this inspection was limited to basins directly owned by the City. There are 120 basins within the boundaries of the City, with only 24 directly owned by the City. The remainder are a combination of privately held basins, some by the original subdivision developer, Home Owner's Association (HOA), commercial businesses, etc.

To help streamline this process, the City developed an ArcCollector smartphone app that allowed for direct tracking of these inspections in ArcGIS.



As a private owner, you may have received a form letter that indicated some items that may need attention such as excessive vegetative growth, etc. We found that quite a few basins had excessive weed growth that was reducing the overall volume capacity of the permitted basin.



We wish to thank the many owners that have been working to address these findings and making our recent EPA review a successful one. We will be working to enhance our web presence with additional outreach and education information concerning the program in the coming months.

WASHINGTON POLICE DEPARTMENT

We would like for the great citizens of Washington to be mindful of a couple of issues this season.

The first is this is prime time for "telephone scams." Scammers from around the world are calling citizens stating such things as "you missed a court date and must pay X amount to stay out of jail" and "you missed a

jury summons and for X amount you won't be arrested." Some scammers state that a relative has been arrested and needs X amount to get out of jail and recently some callers have identified themselves as members of a police department or sheriff's office stating that you have not paid a ticket and for X amount you can have the ticket dismissed.

Please remember to never give any personal information over the phone and police will never call asking for money over the phone. All of these are scams and local police should be notified if you get one of these calls.

The second is this is the time of year for slick roads and extended hours of darkness. Please be sure that your



windshields are clear before you drive. Snow and frost on any part of your windshield contributes to obstructed driving vision. Continue to realize that it takes longer to stop your vehicle this time of year because of road conditions as well. Finally, PLEASE do not text or talk on your phone while you are driving!
