

## 2019 PRIMARY ELECTION

Nomination papers for the upcoming 2019 Primary Election are available for circulation.

Nominating petitions may be circulated beginning August 28, 2018. Filing dates for candidates seeking nomination at the Consolidated Primary Election on February 26, 2019 are **November 19-26, 2018**. Please note that City Hall offices will be closed on the following days for the Thanksgiving holiday: Thursday, November 22<sup>nd</sup>, and Friday, November 23<sup>rd</sup>. Petitions may be filed with the City Clerk at City Hall offices on the following dates: November 19<sup>th</sup>, 20<sup>th</sup>, 21<sup>st</sup>, and 26<sup>th</sup> between the hours of 8:00 a.m. and 5:00 p.m.

Nomination papers can be picked up at the office of the City Clerk, 301 Walnut Street or are available below. Please note that the Statement of Economic Interest form must be filed with the Tazewell County Clerk at 11 S. 4<sup>th</sup> Street, Suite 203, Pekin, IL 61554. The County will mail you the receipt and a copy will need to be filed in the City Clerk's office with your nomination papers.
